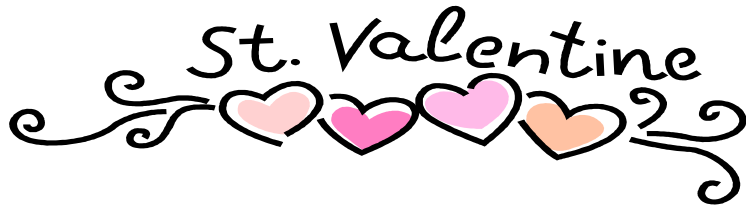

### Recipe of the Month: Awesome Cheesecake

Crust:

- 2 cups graham cracker crumbs
- 1/4 cup sugar
- 1/2 cup melted butter

Filling:

- 3 (8 oz.) packages of cream cheese
- 1 1/2 cup sugar
- 1/8 tsp. salt
- 4 eggs
- 1 tsp. vanilla

Preheat oven to 350 degrees. Crust: Mix all crust ingredients with a spoon. Pat down into a springform pan. Chill crust while making the filling. Filling: Beat the cream cheese, sugar, and salt. Add eggs, one at a time. Add vanilla. Bake 55 minutes at 350 degrees. Remove from oven and let stand for 15 minutes.
