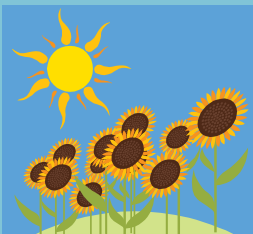

## DCFS Hotline basics:

All of the CASAs are mandated reporters and sometimes things can get confusing when DCFS uses terminology or timelines that we are not familiar with. Here is a rundown of how a hotline call works.

First a mandated reporter, such as a CASA, will call the hotline number, 1-800-25-ABUSE to report concerns of abuse occurring in a child's home.

The call is picked up by the State Central Registry (SCR) Staff in Springfield, IL. That person answering the call determines if the situation that is being reported meets any of the allegation requirements through DCFS. If the incident meets the requirements than the SCR staff person creates a ticket and all the information about the incident and persons involved is sent to the local county DCFS office.

The information is now considered an open investigation and is handed off to an investigator. This DCFS investigator has 24 hours from the time the investigation is received at the local office to make contact with the child/family. An investigation can only be open for 60 days, so the investigator makes every attempt to see the child/family as soon as possible. At the end of the investigation there will be a finding of unfounded or indicated. If a CASA was the reporter of the abuse then the CASA will receive a letter by mail from DCFS letting them know the outcome of the investigation.

Sometimes when a mandated reporter calls the hotline and the incident or concern that is being reported does not rise to the level of abuse/neglect and there is an open foster care case, the SCR staff per-

son will pass on a related information report. This report is not sent to a DCFS investigator, but is sent on to the DCFS or private agency placement worker to review.

There are also times when the situation or incident is not considered abuse/neglect and there is no related information passed on. This means that there is no investigation or staff looking into the concern.

A lot of times CASA has called in a concern about one of our CASA foster children and believed that an investigation was started when really it was only sent to the case worker. The SCR personnel should be able to clarify if it was taken as an investigation or as related information only. Hopefully this helps give a better understanding of how a hotline call is handled.

### Turkey Taco Black Bean Soup:

**Provided by Debbie Vettore from the CASA Cookbook**

- 1 pkg. ground turkey
- 1 pkg. taco seasoning mix
- 1 small onion
- 2 garlic cloves, chopped
- 1 tsp. cilantro
- 1 (14.5 oz.) can of diced tomatoes
- 1 (15 oz.) can of black beans
- 1 tsp. olive oil



Fry turkey in large skillet. Add chopped onion, taco mix, garlic cloves, tomatoes, and cilantro. Cook for 2 to 3 minutes. Stir in black beans and olive oil. Simmer until bubbling and salt to taste. Serve with cornbread or tortilla chips. Serves 4

### Must Do's as a CASA:

1. See your CASA child/children at least monthly
2. Keep in touch with the case worker on the case
3. Turn in court reports two weeks before court date
4. Attend court dates for your CASA case
5. Keep in touch with the parents on the case
