### REMINDER about Court Reports:

As you know, we are now turning in our court reports 3 days before the court hearing. Therefore, we need your court reports 10 days before the court hearing — to give us at least a week to work on them before the reports have to be submitted. If you need to make a final call or check on some final information, don't worry about it. Send in the court report so we can begin working on it. You can then call or e-mail us with any additional information. It is much easier for us to add to, or change, some part of the report, than to do the entire court report in a day or two, which has become more difficult because we now have over 300 cases. Also, remember we want to have a chance to send the completed report to you so you may review it before we submit the report. We want to be sure the report provides accurate information. Your cooperation will be greatly appreciated.
