Recipe of the Month: Citrus Shrimp

1/ 2 cup melted butter	1/ 2 cup of sugar
1 T. Citrus Grill Seasonin	1/ 2 cup of white
8 oz. jumbo shrimp-raw,	balsamic vinegar
Peeled, and deveined	1 T. Citrus Grill Season
1/ 2 cup medium red onion-	1/ 2 cup pineapple
Cut into 1-1/ 2" chunks	puree (fresh or canned)
1 green bell pepper, cut into	2 T. butter
1-1/ 2" chunks	

Mix melted butter and one tablespoon seasoning. Pour over the shrimp and vegetables. Then toss to coat. Add shrimp and vegetables to a grill basket over grill on medium-high heat. Stir and baste with butter every 1 to 2 minutes. Grill shrimp and vegetables for 5 to 7 minutes or until the shrimp are opaque and slightly pink; stirring throughout cooking. In heavy sauce pan, mix sugar and vinegar and heat over medium heat until the sauce turns golden brown. Add Seasoning and pineapple puree. Heat until well blended. Gradually stir in butter. Remove from heat. Pour into a serving bowl and use as a dipping sauce for grilled shrimp and vegetables.
