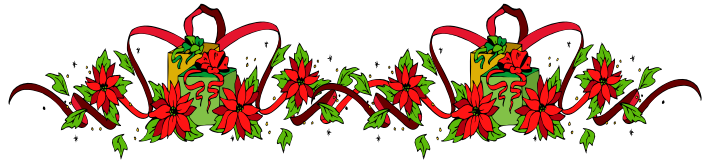

### Egg Nog

2 large eggs  
 1 ( 14 oz. ) can of Eagle Brand sweetened, condensed milk  
 1/4 tsp of salt  
 1/2 pt. whipping cream, whipped  
 1 tsp. vanilla  
 1 quart of milk  
 1 oz. of rum extract  
 Vanilla ice cream  
 nutmeg

Beat eggs well. Add Eagle Brand milk, vanilla, and salt. Blend well and then gradually add 1 qt. milk. Fold in whipped cream. Add rum extract and scoops of ice cream. Sprinkle with nutmeg.
