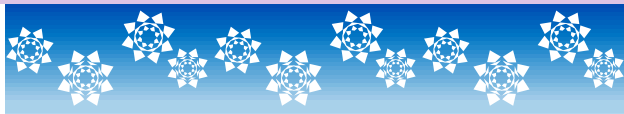
Also, there will be NO Advocate Support Group in January. We will meet again in February.
